STATEMENT REGARDING DESCRIPTON OF DISTRIBUTION OF ASSETS ON DISSOLUTION

In the event of a dissolution of Castellina Condominiums Owners Association, Inc. (the "Association"), the property and assets of the Association remaining after providing for all obligations of the Association shall be distributed pursuant to Article 134 of the Colorado Revised Nonprofit Corporation Act, C.R.S. § 7-121-101, et seq.
