- 1. Approves and accepts the attached estimate of Advanced Hydronics, LLC in the amount of \$35,169.36 for repair and partial replacement of the Building 6 boiler system, and directs that all such work be undertaken as soon as possible.
- 2. Approves the purchase of an extended warranty or warranties for such work and parts, if available, for a total amount not to exceed \$500.00, or such other amount as the Board of Directors may approve at a meeting called for such purpose.
- 3. Approves levying a Special Assessment against the Building 6 Units for the cost of such work and warranty, with the option to pay in three (3) installments.
- 4. Directs and authorizes all other necessary and appropriate acts to carry out the foregoing resolutions.
