2. Motion to approve/waive notice of meeting.

Discussion ensued:

Barton feels like two neighboring conflicting looks with Brian's deck. Changing the color adding the clad. Barton would like more coordination with Billy Dimas unit and suggested wood railings like Billy Dimis would be his preference.

Brina noted most of the high-end condos in the mountain village have metal railings for look and lower maintenance than wood railings.

Jim Tholen felt that other owners were looking for a modernization of the decks. The big round log looks really dated and suggested something more temporary. If everything must match, then we won't get off the big log look.
