## Minutes

1. Roll call, determination of quorum and certification of proxies.

Barton called the Board Meeting to order at 3:12 PM.

2. Motion to approve/waive notice of meeting.

John DeGenova made a motion to approve notice of the meeting. Barton Prideaux seconded the motion, and it passed unanimously.

- 3. Determination of quorum of members Majority of the total number of members entitled to cast, or of members holding proxies and entitled to cast fifty percent (50%) of the votes of members.

  - b. Documents: Jim Tholen has to hire an attorney to prepare the filing. Barton Prideaux is asking for approval from the Board for Barton to sign the document. Jim Tholen noted the town of Mountain Village said we need to amend the plat. The document is done on behalf of the HOA with the next construction agreement, Jim Tholen will reimburse the HOA for the time Joe Solomon did. Jim Tholen will pay a \$5,000.00 deposit to the HOA and the cost will be deducted from the HOA.

  - c. Brian Brunner noted to the Board he walked the property this weekend and

noticed the post for decks and coloring. He would like to set a standard for steel supports and railings as part of the aesthetics for the HOA and opened it up to the floor.

Tom Thorpe suggested that the design has to be compatible and find a way to make it uniform.

John Degenova 's question is how we get to standard steel deck plans. Brian Brunner noted his decks were approved with ballasts and handrails. Brian needs to have log cladding but suggests this gets removed in the future.
